ARTICLES OF INCORPORATION

Article VI - Initial Board of Directors

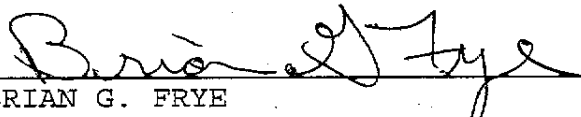

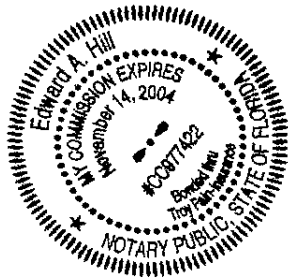
