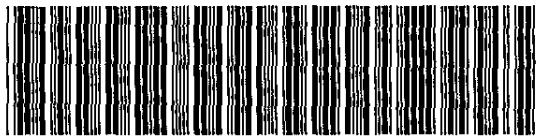

**ARTICLE I  
NAME**


