# APPICLES OF INCORPORATION

OF
YILIAM CAFÉ RESTAURANT, INC. following Articles of Incorporation, for the purpose of creating a corporation under the Laws of the State of Florida.

#### ARTICLE I - NAME

#### ARTICLE XIII - BY-LAWS
