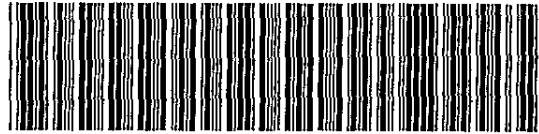

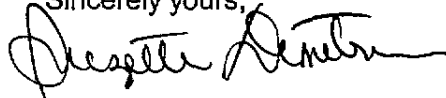

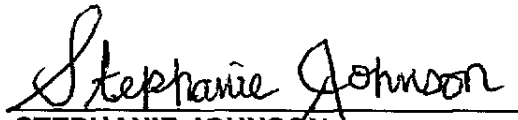
Bylaws
