

ARTICLE ONE - NAME AND PURPOSE

SECRETARY OF STATE

The name of this corporation shall be CHRISTIAN ARTS & PUBLISHING UNLIMITED, INC. and it is organized for the purpose of printing and publishing materials and documents and for all other lawful purposes for which corporations may be organized.


ARTICLE TWO - PRINCIPAL OFFICE


