### ARTICLES OF INCORPORATION

OF

LAKESIDE TRUCKING, INC.

### ARTICLE I - NAME

The name of this corporation is LAKESIDE TRUCKING, INC.

# ARTICLE II - PURPOSE

This corporation is organized for the purpose of engaging in the business of truck delivery, hauling products and truck related matters or any other lawful business and to do anything necessary, proper, advisable, or convenient, for the accomplishment of said purposes, and to do all and other things incidental to them, or connected with them, that are not forbidden by the Florida corporation laws or by other laws, or by these Articles of Incorporation, and to carry out said purpose in any state, territory, district, or possession of the United States or in any foreign country, district, or possession of the United States, or by the laws of that state, territory, district, or possession of the United States, or by the foreign country.

### <u>ARTICLE III - CAPITAL STOCK</u>

The sum of the par value of all shares of capital stock of the corporation that have been issued shall be the stated capital of the corporation at any particular time.
