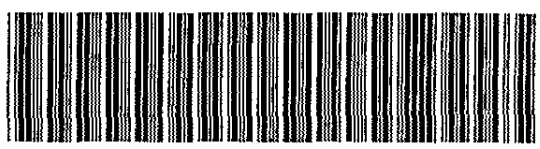

OF
