# ARTICLES OF INCORPORATION OF DARLING'S SPECIAL HOME CARE FACILITY, INC.

### Corporate Name Article I.

The name of this corporation is **DARLING'S SPECIAL HOME CARE FACILITY, INC.**, and its principal place of business is to be located at, 16640 S.W. 103rd Place, Miami, FL 33157.

### Article II. Nature of Business and Powers
