**ARTICLES OF INCORPORATION
OF
DARLING'S SPECIAL HOME CARE FACILITY, INC.**

Article I. Corporate Name

The name of this corporation is DARLING'S SPECIAL HOME CARE FACILITY, INC., and its principal place of business is to be located at, 16640 S.W. 103rd Place, Miami, FL 33157.

Article II. Nature of Business and Powers

The general nature of the business to be transacted by this corporation is to engage in any and all business permitted under the laws of the State of Florida.

Article III. Capital Structure

A. The Board of Directors can create any type of Capital Structure necessary for the operation of the corporation. There can be different stocks of Par Value and Non-Par Value.
