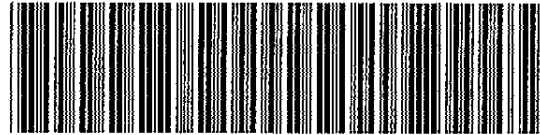

ARTICLE I. NAME

The name of this corporation is
MIKE MANCHESTER STUCCO, INC.

ARTICLE II. DURATION

This corporation shall have perpetual existence.

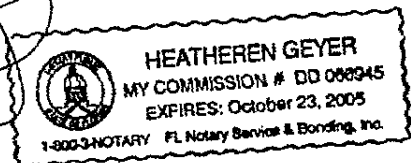


