For the purpose of forming a corporation for profit under the general incorporation laws of the State of Florida, it is respectfully requested of the Secretary of State the approval of such incorporation under the following Articles.

ARTICLE I

The name of this corporation shall be <u>KILRKAY TALENT AGENCY PRODUCTIONS</u>, <u>INC</u>, principal place of business shall be at 200 SW 132 Way #109, Pembroke Pines, FL 33027 with the right to change and move said principal place of business and establish such other offices and place of business within or without the State of Florida as the Board of Directors may from time to time deem proper.

ARTICLE II
