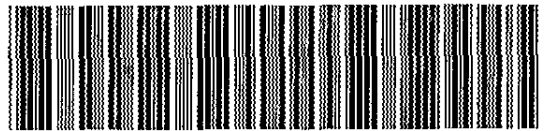

The name of the corporation shall be RENEGADE PARTNERS, INC.
