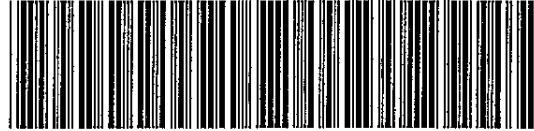

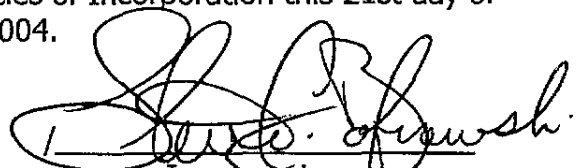
Article X By Laws

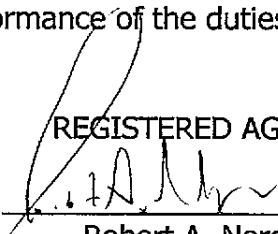
