ARTICLE ONE

The name of this corporation is: ANA J. SOLIS M.D., P.A.

The principal office and mailing address of this corporation is: 1200 N.W. 78 AVENUE-STE.#216, MIAMI, FL. 33126

ARTICLE TWO

NATURE OF BUSINESS

This corporation may engage in any activity or business related with the medical profession such as a private practician or clinic that are permitted under the laws of the United States of America and the laws of the State of Florida.

ARTICLE THREE

DURATION

This medical professional corporation shall have perpetual existence unless somer dissolved in accordance with the laws of the State of Florida. The date on which corporate existence shall begin is: UPON APPROVAL BY SECRETARY - OF STATE.

ARTICLE FOUR

CAPITAL STOCK

This corporation is authorized to issue shares of stock as follows:

BY LAWS
