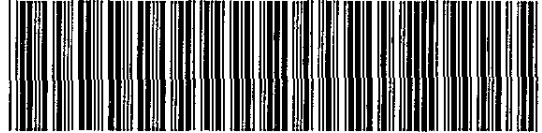

ARTICLE ONE


ARTICLE TWELVE


