## ARTICLES OF INCORPORATION OF MORALES HARVESTING, INC.

The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract, hereby forms a corporation for profit under the laws of the State of Florida.

#### **ARTICLE I - NAME**

The name of the corporation is MORALES HARVESTING, INC.

#### **ARTICLE II - NATURE OF BUSINESS**
