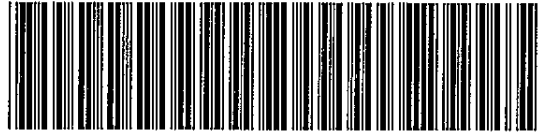

ARTICLES OF INCORPORATION
OF
MOAN ENTERPRISES, INC.

ARTICLE I - NAME

The name of this corporation is MOAN ENTERPRISES, INC.

ARTICLE II - DURATION

This corporation shall exist perpetually.

ARTICLE III - PURPOSE




