**ARTICLES OF INCORPORATION**  
**OF**

**ARTICLE I - NAME**

The name of this corporation is CANDICE LEIGH'S HAIR DESIGN, INC.

**ARTICLE II - DURATION**

This corporation shall exist perpetually.
