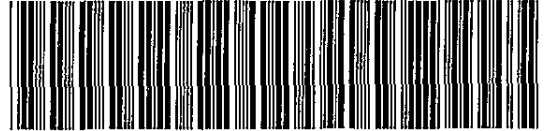

ARTICLES OF INCORPORATION
OF

Adrenaline Studios Corporation

ARTICLE ONE:

The name of the corporation is: Adrenaline Studios Corporation

ARTICLE TWO:

The period of its duration is perpetual.

ARTICLE THREE:

The purpose for which the corporation is organized is the transaction of any and all lawful business for which corporations may be incorporated under the Florida Corporation Act.

ARTICLE FOUR:

The aggregate number of shares which the corporation shall have authority to issue is one hundred thousand (100,000) of the par value of one dollar (\$1.00) each.

ARTICLE FIVE:

The corporation will not commence business until it has received for the issuance of shares, consideration of the value of \$500. 00 consisting of money, labor done or property actually received.

ARTICLE SIX:

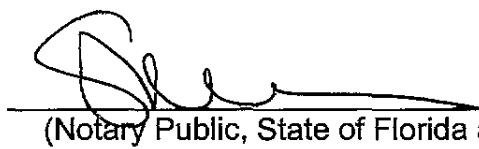
