The general nature of the business to be transacted by this corporation shall be as follows:

B. 

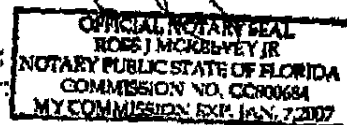
