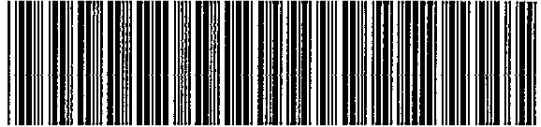

ARTICLE I. NAME

The name of this corporation is K.S.K. CONCRETE & CONSTRUCTION, INC.


ARTICLE IX. INDEMNIFICATION


