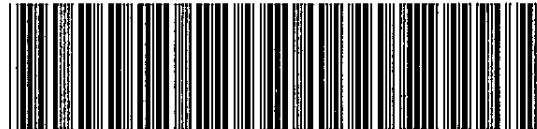

ARTICLES OF INCORPORATION

of

Advanced Design Modular Homes, Inc.

The undersigned sole incorporator, being a natural person competent to contract and desiring to form a corporation in compliance with Chapter 607 and/ or Chapter 621, of the Florida Statutes (Profit), herewith submits the following information:

Article I

*The name of the corporation shall be: **Advanced Design Modular Homes, Inc.***

Article II

Article III

The purpose of this corporation is to engage in any activity or business permitted under the laws of the State of Florida and any other state, country or territory under which it may qualify to do business.
