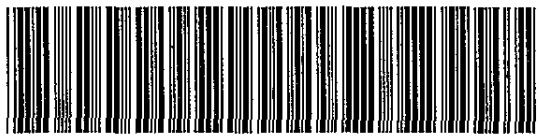

The undersigned incorporator to these Articles of Incorporation, by these articles form a corporation for profit, pursuant to the laws of the State of Florida.

FIRST. The name of the corporation is ORESTES LEY PAINTING AND CLEANING, INC.

SECOND. The period of duration of the corporation is perpetual.

THIRD. The purpose is to engage in any activity permitted under the laws of the United States and Florida.

FOURTH. The aggregate number of shares of Capital Stock which the Corporation has authority to issue is 5000, all of which shall be one class of common stock having a par value of \$ 1.00.

- c. The directors of this Corporation shall have the sole discretion to determine the expenses for which the before-mentioned incorporator shall be reimbursed.


TWELVE. The Corporation reserves the right to amend or repeal any provision contained in these Articles of Incorporation or any amendment to the Articles of Incorporation.
