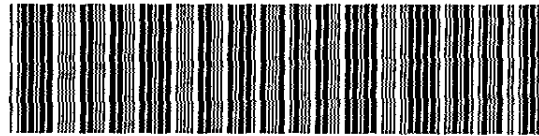



The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, hereby adopts the following articles of incorporation:

**ARTICLE ONE**  
**NAME**

The name of the corporation is RB FINANCIAL ADVISORS INC.

**DURATION**

The term of existence of the corporation is perpetual.

**PURPOSE**


