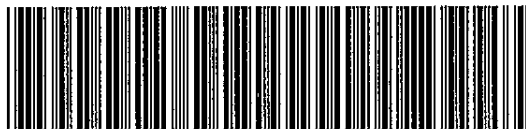



In compliance with the requirements of F.S. Chapter 607, the Florida Business Corporation Act, the undersigned, being a natural person, does hereby act as incorporator in adopting and filing the following Articles of Incorporation for the purpose of organizing a business corporation.

ARTICLE I: NAME

The name of the corporation ("Corporation") is **CARL O. ZEMKE TRASH HAULING SERVICE, INC.**

ARTICLE II: PRINCIPAL OFFICE


