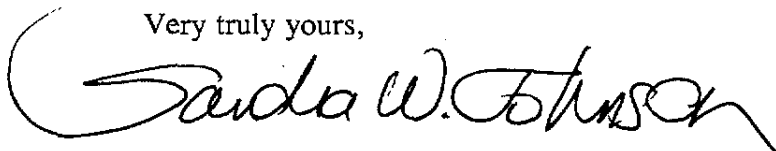

The undersigned, for the purpose of forming a corporation for profit under the laws of Florida, adopts the following Articles of Incorporation:

**Article I
Name**

The name of this corporation shall be KEVIN BLAIR, INC.

**Article II
Principal Office and Mailing Address**

The principal place of business and mailing address of this corporation shall be 5400 Collins Road, Lot 68, Jacksonville, Florida 32244.

**Article III
Capital Stock**

The maximum number of shares of stock which this corporation is authorized to have outstanding at any one time is 1,000 shares of common stock having a par value of \$1.00 per share.

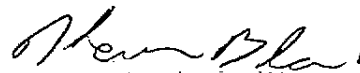
