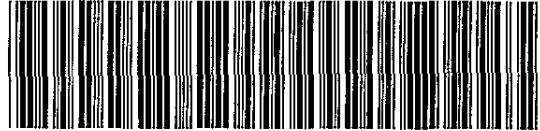

**ARTICLE OF INCORPORATION
OF
TOLEDO CARPET Cleaning, Inc.**

ARTICLE I: NAME

The name of this corporation is **Toledo Carpet Cleaning, Inc.** The mailing address of the corporation is 3058 Egrets Landing, Lake Mary, FL 32746.

ARTICLE II: DURATION

This corporation shall have perpetual existence.

ARTICLE III: PURPOSE


ARTICLE IX: INDEMNIFICATION






