This Corporation is authorized to issue one hundred thousand (100,000) shares of penny (\$0.01) par value stock.

Article VI - Initial Registered Office and Agent

Article IX - By-Laws

This corporation reserves the right to amend, alter, change or repeal any provisions contained in these Articles of Incorporation in the manner now or hereafter prescribed by statute, and all rights conferred upon the stockholders herein are subject to this reservation.


