

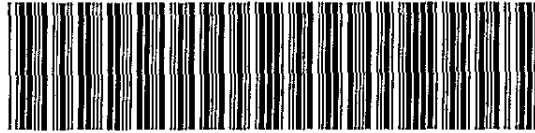

**ARTICLES OF INCORPORATION
OF
WOOD FURNITURE DESIGNS OF FLORIDA, INC.**

The undersigned adopt the following Articles of Incorporation to form a corporation under the laws of the State of Florida

ARTICLE I – NAME

The name of the corporation shall be Wood Furniture Designs of Florida, Inc.

ARTICLE II – COMMENCEMENT AND DURATION

The corporation shall commence its existence on March 1, 2004 and shall exist perpetually unless sooner dissolved according to law.

ARTICLE III – ADDRESS

ARTICLE IV – STATED CAPITAL
