# ATTACHMENT TO ARTICLES OF AMENDMENT REXALT GROVES CORPORATION

Article V of the Articles shall be deleted in their entirety and amended as follows:

#### ARTICLE V

## CAPITAL STOCK

There shall be two (2) classes of shares: Class A Voting and Class B Non-voting

There shall be a total of two thousand and five hundred (2.500) Class A voting shares with a par value of one cent (\$0.01) per share. Each share of voting stock shall be entitled to one vote.

There shall be a total of seven thousand and five hundred (7,500) Class B non-voting shares with a par value of one cent (\$0.01) per share.

Holders of the capital stock shall not have any preemptive rights to purchase any new shares of stock or securities, or rights to acquire stock or securities of the Corporation. Cumulative voting shall not be allowed in the election of its directors or for any other purpose.
