GENERAL DISTRIBUTIONS, TWO.

The undersigned, in order to form a comporation for the purposes hereinafter stated, by and under the provisions of the Statutes of the State of Florida, do hereby subscribe to those Articles of Incorporation.

ARTICLE I - NAME

The name of this corporation is:

ARTICLE II - DEPATION

APPICIE III - PURPOSE

This comparation is organized for the following purposes:
