

### Article IX



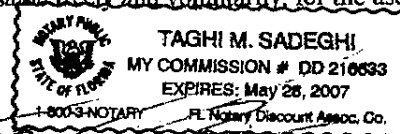
