# Articles of Incorporation of OLIVIA PROPERTIES INC.

#### 1. Corporate Name

The name of the Corporation shall be: OLIVIA PROPERTIES INC. The principal place of business of this corporation shall be 1411 EL CAJON CT., WINTER SPRINGS, FL. 32708.
