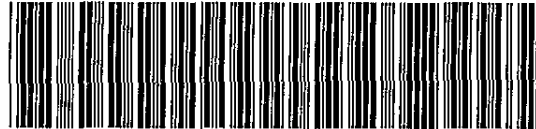

ARTICLE I




