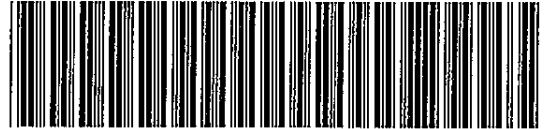

ARTICLE I

CORPORATE NAME
