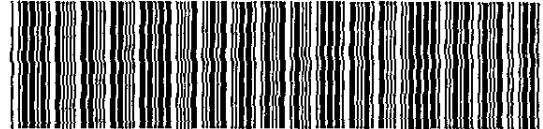


THIRD: The date of each amendment's adoption: April 25, 2004.





being removed as position of Secretary/Director.


