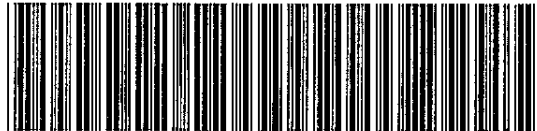

Complying with Chapters 621 and 607, Florida Statutes, the undersigned natural person is the incorporator of the corporation, and adopts and files the following articles of incorporation for the purpose of organizing a professional services corporation.

ARTICLE VI


