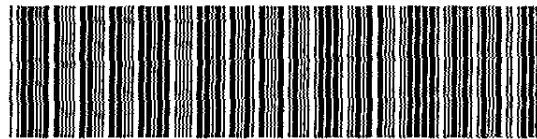

Article I - Name

The name of this corporation is **CROSS CREEK REALTY SERVICES, INC.**

This corporation shall have a perpetual existence, commencing on the date of filing these articles with the Department of State.

Article III - Purpose
