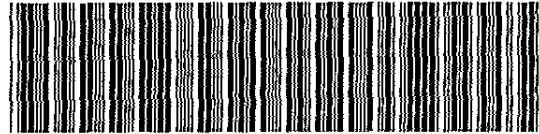

### ARTICLE I

#### NAME

The name of the Corporation is Michael L. Harvey, P.A.. The principal office address and the mailing address of said Corporation is 13633 Bromley Point Drive Jacksonville, Florida 32225.

### ARTICLE II

#### DURATION

This corporation shall have perpetual existence commencing on the date of this filing of these Articles with the Department of State.

### ARTICLE III

#### PURPOSE

This corporation is organized pursuant to the Professional Service Corporation and Limited Liability Company Act of the State of Florida for the purpose of transacting any or all lawful business of licensed professional attorneys under Chapter 621, Florida Statutes, as now exists or may hereafter be amended.

## ARTICLE IV

### CAPITAL STOCK

This corporation is authorized to issue 100 shares of no par value stock which shall be designated as "Common Stock".

## ARTICLE V

### PRE-EMPTIVE RIGHTS

Every shareholder, upon the sale for cash of any new stock of this corporation, shall have the right to purchase his or her pro-rata share thereof (as nearly as may be done without issuance of fractional shares) at the price at which it is offered to others.

## ARTICLE VI

### INITIAL REGISTERED OFFICE AND AGENT

## ARTICLE VII

### INITIAL BOARD OF DIRECTORS

### INDEMNIFICATION



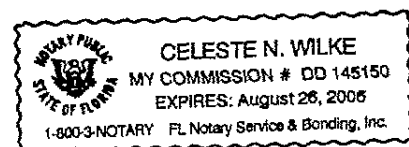


