**ARTICLES OF INCORPORATION
OF
NET GALAXIES, INC.**

THE UNDERSIGNED, acting as the sole Incorporator of Net Galaxies, Inc. ("Corporation") under the Florida Business Corporation Act ("FBCA"), Chapter 607, Florida Statutes, as hereafter amended and modified, hereby adopts the following Articles of Incorporation for the Corporation.

**ARTICLE I
NAME**

The name of the Corporation is: **Net Galaxies, Inc.**

**ARTICLE II
PRINCIPAL ADDRESS AND MAILING ADDRESS**

The address of the principal office and mailing address of the corporation is 16467 Turnbury Oak Dr., Odessa, Florida 33556.

**ARTICLE III
BUSINESS AND ACTIVITIES**

The Corporation may, and is authorized to engage in any activity or business permitted under the laws of the United States and the State of Florida.



Without limiting the foregoing in any way, the corporation shall indemnify any Officer or Director who was or is a party to any proceeding (including by or in the right of the Corporation) against liability incurred in connection with such proceeding, including any appeal thereof, if such Officer or director acted in good faith and in a manner he reasonably believed to be in, or not opposed to, the best interests of the Corporation and, with respect to any criminal action or proceeding, had no reasonable cause to believe his conduct unlawful.
