Article 1

TALLAHASSEE, FLORIDA

Name. The name of this Corporation is DIXIE LAND CLEARING, INC.

Article II

<u>Principal Office</u>: The principal place of business and mailing address of this corporation shall be: P.O. Box 752, Cross City, FL 32628
