## ARTICLES OF INCORPORATION FOR A EXPERT INSPECTIONS, INC.

The undersigned subscribers hereby associate themselves together to form a corporation for profit under the laws of the STATE OF FLORDIA: and hereby adopt the following ARTICLES OF INCORPORATION.

#### ARTICLE I NAME
