ARTICLE I - NAME

The name of this corporation is TRACY CANNING, P.A.

ARTICLE II - ADDRESS

The mailing address of the corporation is 14545 Tanja King Blvd., Orlando, Florida 32828.

ARTICLE III - DURATION

This corporation shall exist perpetually.

ARTICLE IV - PURPOSE

It is intended that this corporation may conduct and transact any business lawfully authorized and not prohibited by Chapter 607, *Florida Statute*, as the same be from time to time amended.
