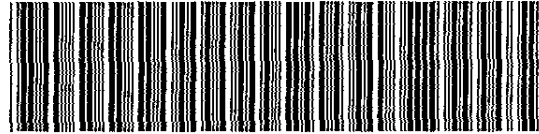

ARTICLE I - NAME

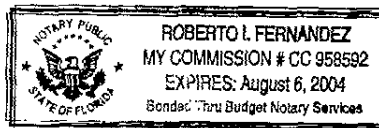
