ARTICLES OF INCORPORATION OF

(a Florida corporation)

THE UNDERSIGNED, acting as sole incorporator of THE LASER CENTER AT FLORIDA EYE CLINIC, INC., under Chapter 607 of the Florida Statutes, hereby adopts the following Articles of Incorporation for such corporation:

<u>ARTICLE I</u> Name

The name of the corporation is THE LASER CENTER AT FLORIDA EYE CLINIC, INC.

ARTICLE II Principal Office and Mailing Address

The principal office and mailing address of the corporation is 160 Boston Avenue, Altamonte Springs, FL 32701. The location of the principal office shall be subject to change as may be provided in bylaws duly adopted by the corporation.
