ARTICLES OF INCORPORATION OF CNL RESTAURANT BROKERAGE, INC.

ARTICLE I - NAME

The name of this corporation is CNL RESTAURANT BROKERAGE, INC.

ARTICLE II - PRINCIPAL OFFICE AND MAILING ADDRESS

ARTICLE III - PURPOSE AND GENERAL POWERS
