Article I – NAME

The name of the corporation is TIGHTEN SPOKES, INC.

Article II – DURATION

This corporation shall exist perpetually unless dissolved according to Florida law.

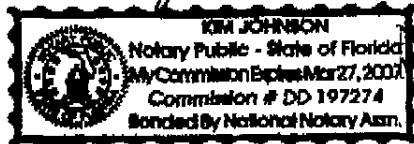
