Articles of Correction
to the
Articles of Incorporation of

(Document No. P04000051824)

Pursuant to the provisions of Section 607.0124 of the Florida Business Corporation Act, the undersigned professional corporation adopts the following Articles of Correction to the Articles of Incorporation of Eugenio Bricio, M.D., P.A.:

1. The document being corrected is the Articles of Incorporation for this corporation filed on March 23, 2004 under document no. P04000051824.

2. The defects to be corrected are (i) a scrivener error in Article FOURTH wherein the word "podiatry" should have been "medicine"; and (ii) referencing in Article SEVENTH that the incorporator was Eugenio Bricio, M.D., while the incorporator actually was, and the person who actually signed the articles of incorporation was Ted Klein.

3. Article FOURTH of the Articles of Incorporation is hereby deleted in its entirety and the following is substituted in its place:

FOURTH: This corporation is authorized to issue Five Hundred (500) shares of common stock which shall be designated as "common shares". All of said stock shall be payable in cash, or payable in property (real or personal), labor or services in lieu of cash, at a just valuation to be fixed by the board of directors of this corporation. The shares of stock in this Corporation may only be issued to those individuals who are duly licensed to practice medicine in the State of Florida and stockholders of this Corporation may not enter into a voting trust agreement or any other type of agreement vesting in another person the authority to exercise the voting power of any or all of his shares.

4. Article SEVENTH of the articles of incorporation is corrected by substituting Ted Klein for Eugenio Bricio.

5. These articles of correction shall be effective as of March 23, 2004.

6. Directors and officers of this corporation have not yet been elected or appointed, as the case may be and therefore these
