

- 1. The Corporation hereby increases the number of authorized shares of its common stock, par value \$.01 per share, from 10,000,000 shares to 30,000,000 shares, and, to reflect such increase, hereby amends and restates Section (a) of Article III of its Articles of Incorporation of the Corporation as follows:
 - (a) The aggregate number of shares of stock of all classes that the Corporation shall have authority to issue is 36,000,000 shares, of which 30,000,000 shares shall be common stock, par value \$.01 per share ("Common Stock"), and of which 6,000,000 shares shall be preferred stock, no par value ("Preferred Stock").

The number of votes cast for the amendment by the shareholders, in the manner required by the FBCA and the Corporation's Articles of Incorporation, was sufficient for approval. - 3. These Articles of Amendment shall become effective as of the close of business on the date of the filing of these Articles of Amendment with the Secretary of State of Florida.
