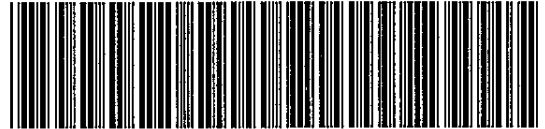



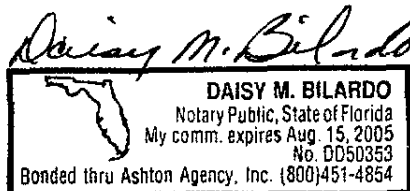
ARTICLE IX - AMENDMENT TO ARTICLES


